Program Overview

Florida Southern offers a fully Online or flexible Saturday-Hybrid MBA program to accommodate your busy schedule. Along with a foundations of business course, students are enrolled in seven core courses. The curriculum focuses on leadership skills in the global marketplace and provides opportunities for student-faculty collaboration. The program also requires four elective courses which you choose to customize your degree to fit your career goals.

- **Flex Saturday-Hybrid** - Classes meet on campus every other Saturday, with the remaining coursework completed Online, ideal for working professionals who still want face-to-face interactions.
- **Online** - All coursework is completed Online. With access to virtual advising, this option is ideal for working professionals who travel or require the convenience of an Online delivery.

From the moment you enroll, the MBA Director will be assigned as your Academic Advisor, to see you through your experience from start to finish. Your advisor will help you develop an educational plan that matches your schedule and priorities.

Students who have earned a bachelor’s degree from a regionally accredited college or university are eligible to apply for admissions. The Florida Southern MBA program is open to graduates with a degree in any major.

Financial Aid & Scholarships

Tuition deferment may be available to students receiving employer reimbursement. FSC participates in all major federal aid programs including military funding.

MBA Merit Scholarships are a one-time award, ranging from \$500-\$1500. Applicants must submit a GMAT/GRE scores for consideration.

Gain experience while saving money! 25%-100% of tuition can be waived for graduate assistants in exchange for hours worked. Selection is competitive and requires admission to the program, a separate online application, GMAT/GRE scores, and an interview.

Admission Requirements

- Completed online application
- Provide official undergraduate transcripts of all academic work with a minimum 3.0 grade point average (GPA) on a 4.0 scale
- Official GRE/GMAT scores (See waiver criteria below)
- Current résumé
- Personal statement of professional goals (See prompt online)
- Two letters of recommendation

GRE/GMAT Waiver Criteria

To be considered for a test waiver for admission, you must hold a 3.00+ cumulative GPA or higher and meet one of the following criteria:

- Applicant is a graduate of an AACSB-accredited business school with a 3.25+ cumulative GPA
- Applicant is a graduate of Florida Southern College with a 3.25+ cumulative GPA
- Applicant is a graduate of Florida Polytechnic University with a 3.25+ cumulative GPA
- Applicant is a graduate of a regionally accredited institution with a 3.30+ cumulative GPA
- Applicant is a lifetime Beta Gamma Sigma member
- Applicant currently holds a master’s or terminal degree (JD, MD, PhD, etc.)
- Applicant currently holds an active CPA license
- Applicant is a lifetime Beta Gamma Sigma member
- Applicant has a minimum of 3 years of qualifying managerial experience
