RETURNING STUDENTS may visit Portal Registration to make necessary schedule adjustments until August 26, 2024, before 5:00 p.m.

<u>NEW AND TRANSFER STUDENTS</u> may only make schedule adjustments through their academic advisor via the Portal or by completing a schedule adjustment form that <u>must include a faculty advisor's signature</u>. Forms are available on the FSC web site (search FSC, Registrar's Office, Forms and Documents, Schedule Adjustment Form (Add/Drop). The Registrar's Office may make these schedule adjustments until August 26, 2024, at 5:00 p.m.

<u>ALL STUDENTS</u> must contact the Registrar's Office to withdraw from a course beginning August 27, 2024, and prior to 5:00 p.m. on November 1, 2024. <u>W</u> grades will be posted on the student's academic record. All students must obtain signatures from both the course faculty/professor and their advisor on the course withdrawal form in order to withdraw from a course. The student is responsible for submitting the form to the Registrar's Office. Verbal notification to a faculty/professor or failure to attend class does **not** constitute a withdrawal form. Students who abandon a course without filing the appropriate form may receive a failing grade. Course withdrawal forms are available in the Registrar's Office or on the FSC web site.
